Vantage Point assumed operations on the Unit during January, 1991, and has since activated nineteen wells. Vantage Point is viewing the feasibility of returning additional wells to active status when the economics are favorable. Also, this Unit has potential for CO2 flooding and for drilling additional wells to tighten the injection pattern. Extension of LTSI status would keep this wellbore available for future projects and would eliminate economic waste and promote conservation.
