1/16/97 A-Plus Well Service mixed and pumped 59 sacks Class B cement, plug from 1523' to 1000' to cover Gallup top and perforations. Tag cement top at 1066'. Perforated squeeze holes at 300'. Mixed and pumped 94 sacks Class B neat cement. Circulated cement from annulus and left casing full.

1/17/97 Cut off wellhead and installed regulation dry hole marker with 10 sacks of cement.

Casing remaining in hole:

Surface casing: 8-5/8", 24#, J-55 casing to 101'

Production casing: 5-1/2", 15.5#, J-55 to 1660'
