On 7-19-64, ran 53 joints 4-1/2" 9.5# J-55 casing and set at 1714' w/50 sacks class A - 12.5# Gilsonte per sack - 1% Halad-9. Pumped plug down w/oil. On 7-23-64 fraced 1526' to 1532' w/800 BO and 25,000# sand. Put well on pump 7-26-64. Initial gauge to be reported later.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations.
