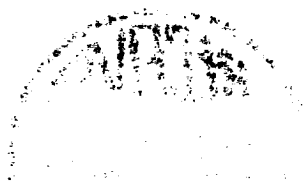
DETAILS OF WORK

It is proposed to drill with rotary tools to a depth of 100+ feet, set 8-5/8" casing and cement to surface w/100+ sax. Thereafter to drill with rotary tools to the top of the producing zone, run electric log and run 5-1/2" casing and cement w/50+ sax. Thereafter to drill in with cable tools, run GRI log, frac through casing w/20,000 gallons of crude and 20,000# sand; swab and test well, with cable tool rig until daily rate of production is established, and complete. The **SW 1/4 Sec. 19**, containing 40 acres, more or less, is dedicated to the well site. Estimated total depth: 3,000 feet.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
