Run 242 joints 2 3/8" tubing landed at 7031 with Baker Model R Packer set at 5130. Surf nipple at 6995-98. Pressured tubing to 2000' for 30 minutes. No leaks. Run 141 joints 1 1/2" flush joint tubing landed at 5603. Installed well head. Switched in Dakota & Mesa Verde zones.

Instructions
