750 gallons regular 15% HCl acid.

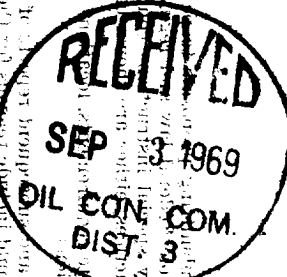
1500 gallons mud acid.

After well has been cleaned up will squeeze with 55 gallons of Jet-Cote 40-C inhibitor mixed with 50 barrels of lease crude.

Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
