FULL DETAILS OF PROPOSED PLAN OF WORK

FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS OF THE COMMISSION

It is proposed to move on rotary rig, pull tubing, cleanout with gas to solid bridge, place 5' calseal or hydramite cap on top of bridge, run 5½" liner from bridge to 75' or 100' inside existing production string. The liner will then be perforated from 4745' to 4805' with 4 shots per foot. Sandoil frac treatment will consist of 10,000 gallons diesel oil, containing 1½ sand per gallon. Drill plug and cleanout to total depth, test, and repotential well. Production of well before repair, 236 MCFD.
