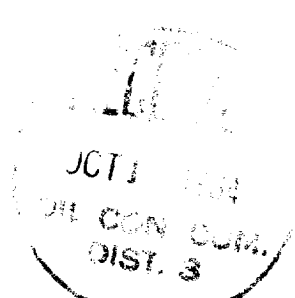

Spudded @ 11:30 pm 8/9/64. Ran 5 jts. 8 5/8" O.D., 24#, J-55 casing (9'.83") set at 96.88'. Cemented w/40 sz. class "C" cement + 2% CaCl₂. Plug down 3115 pm 8/10/64, cement circulated. W.O.C. 15 hr. & tested casing w/400 psi O.K.

Drilled to 1685' T.D. Ran 94 jts. 4 1/2" O.D., 9.5#, J-55 casing (1680.19) set at 1684.84'. Cemented w/50 sz. class "C" cement + 8% gel & 12% Gellionite/sk followed by 75 sz. class "C" cement + 2% gel. Plug down 3115 pm 8/13/64. W.O.C. & completion rig 120 hrs. and tested casing w/1000 psi. O.K.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
