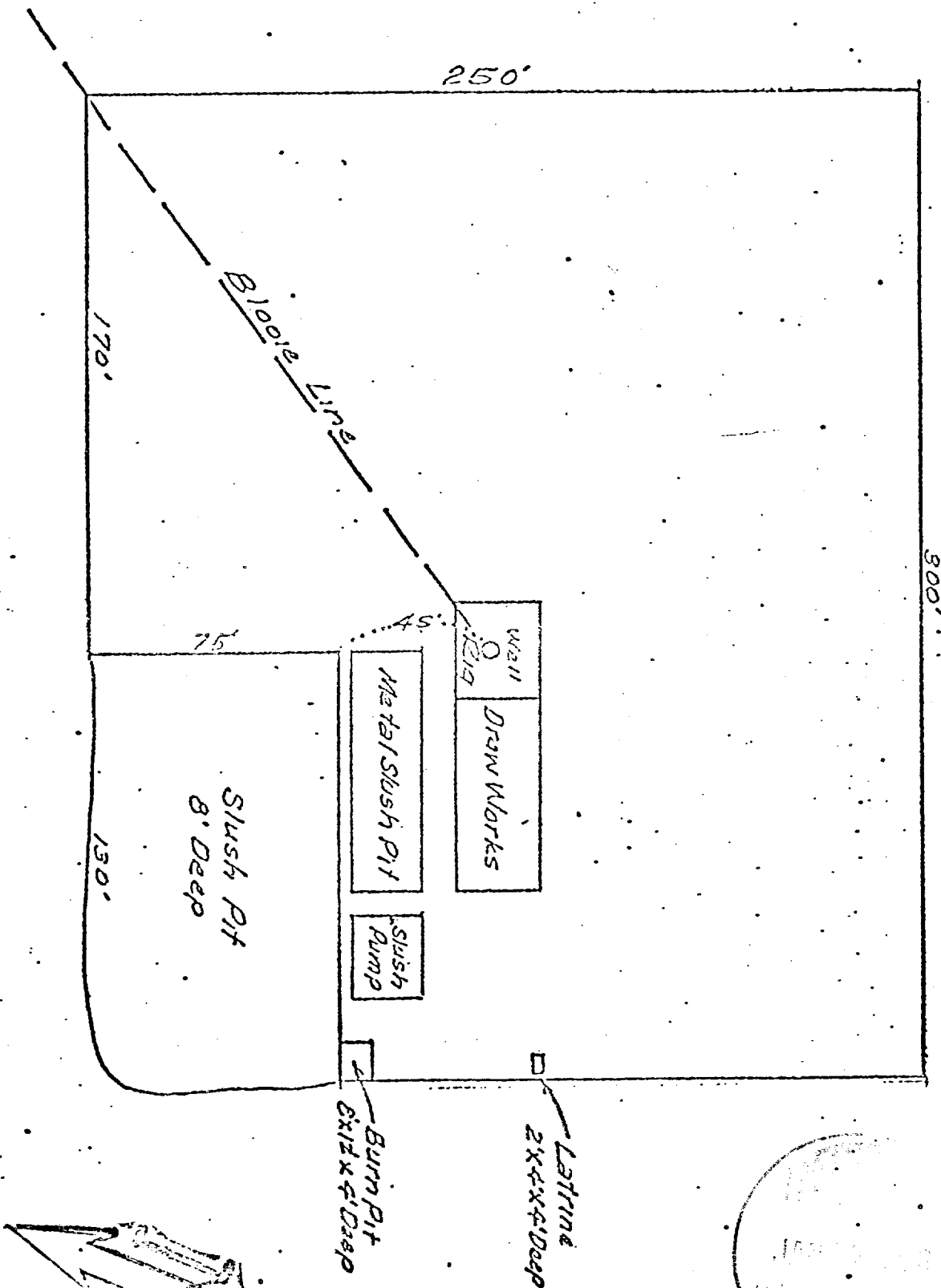

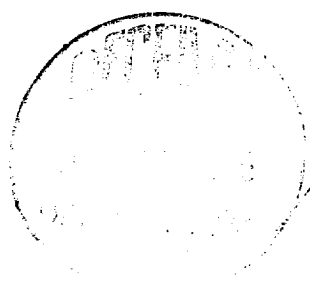
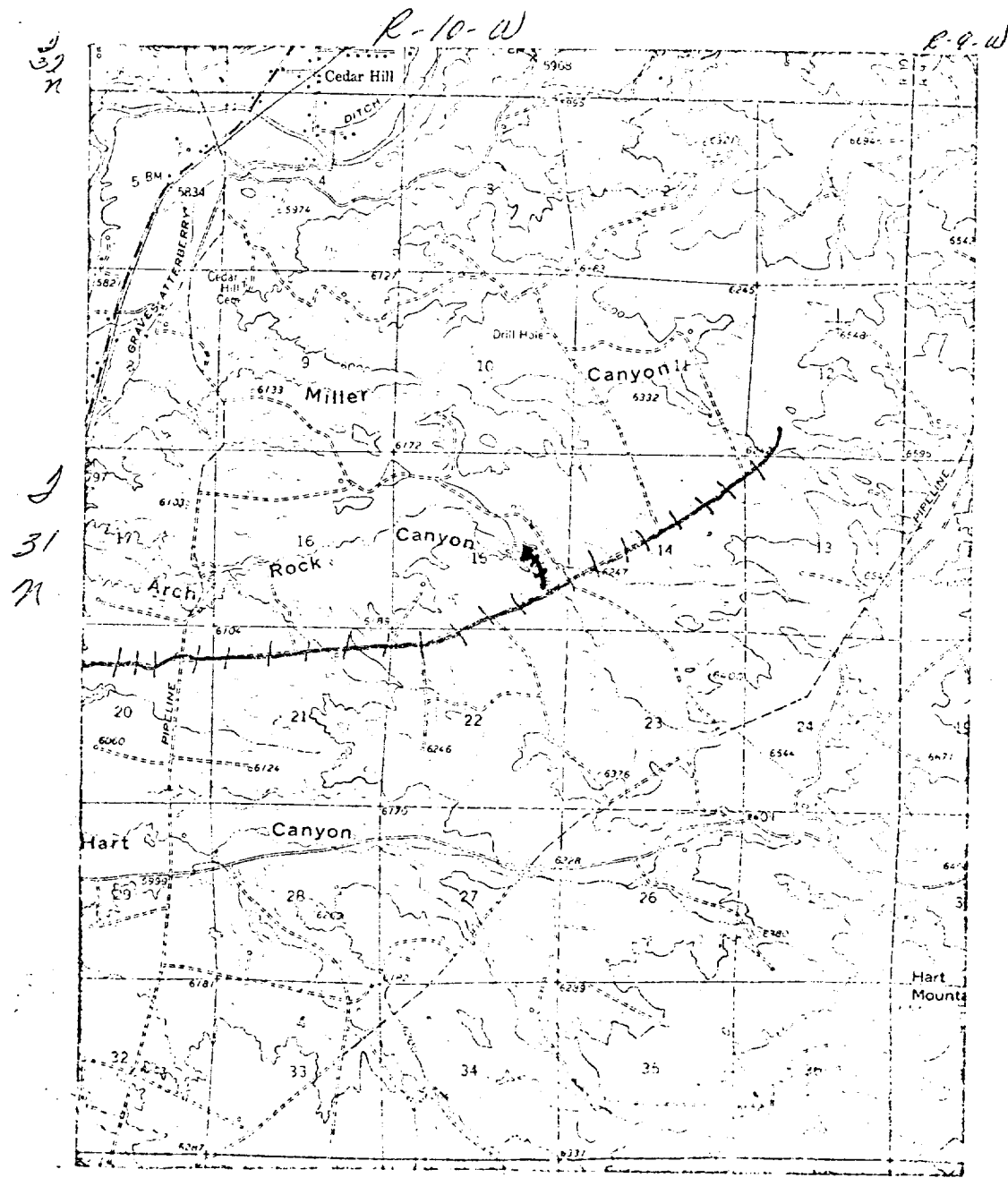

Details regarding existing roads, pipelines, wells, etc.
relative to the above well location are included on the
previously submitted base maps, "Field Road Map" and

The proposed new well location, new roads and new pipeline

roads and pipelines in the vicinity of the proposed new well.

Water for drilling and completion operations will be obtained
from the following location: Graves-Atterbury irrigation ditch,

Waste material will be disposed of by burial in the burn pit,

nor air strip associated with drilling this well. Upon
completion or abandonment of this well, the location will be
cleaned and leveled and a dry hole marker placed, if applicable.
