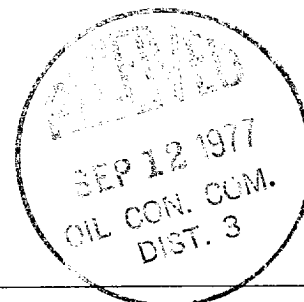

1. Kill well w/water.
2. Pull 1-1/2" & 2-3/8" tbg string & Baker "AD" pkr now set @ 5049'.
3. Set ret BP @ 3550' & spot two sx sand on top.
4. Set pkr @ 3300' & squeeze P.C. perfs 3433-3489 w/200 sx cmt.
5. Reset pkr @ 2900' & WOC 6 hrs; squeeze Fruitland perfs 3068-3110 w/200 sx cmt.
6. Drill out cmt. Test csg to 1000#.
7. Pull ret BP & run prod tbg.
8. Swab well in & blow dry.
9. Complete as Mesa Verde gas well only.
