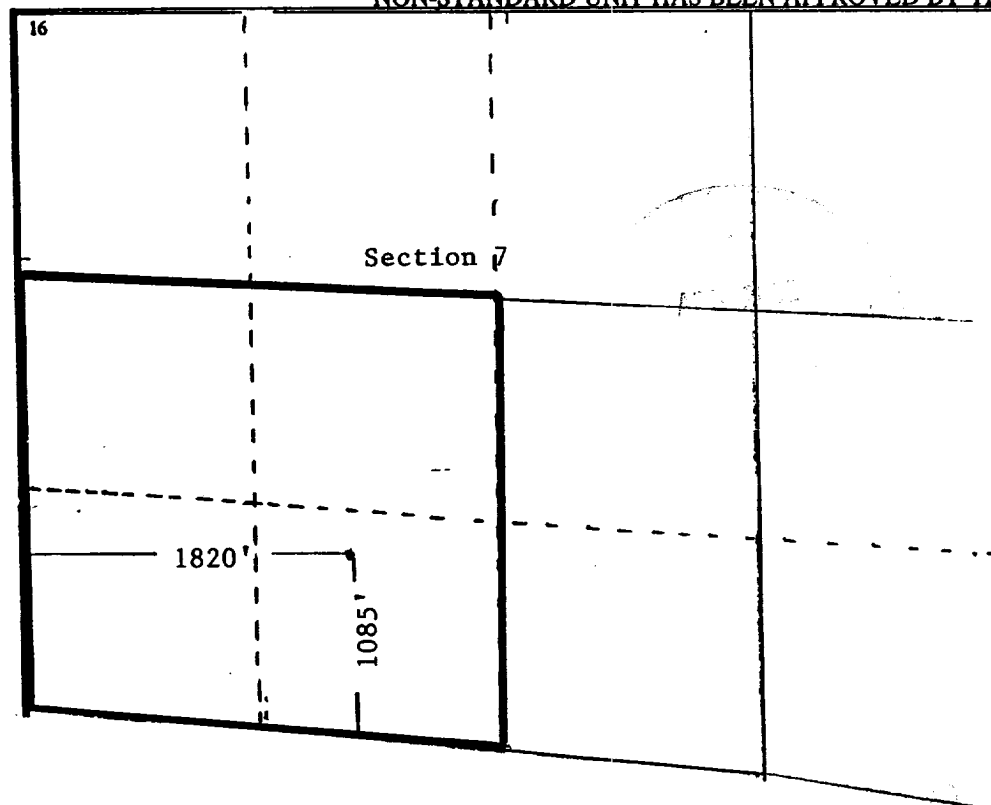

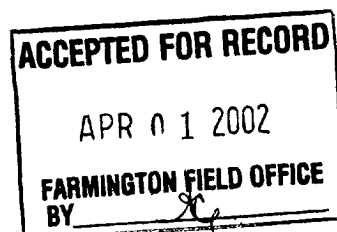
To Whom it May Concern:

Attached is an amended C102 for the San Juan 32-7 #41A. The original dedication plat assigned back in 1981 for the Pictured Cliffs interval was mislabeled S. Los Pinos PC. This is a dual MV/PC well in which the PC interval hadn't produced in years. The mistake was discovered when Phillips put this interval on production after a workover. NMOCD caught the error and they requested a new C102 with the right pool name be filed. Please make changes in your records.
