1. Set Bridge Plug at 2730'.
2. Perforate 2 holes at 1230'. Break down perfs.
3. Squeeze with 100 sxs (118 cu.ft.) C1 "B" with 2% CaCl2. Squeeze to 850 psi.
4. Perforate 2 holes at 450'. Break down perfs.
5. Squeeze with 100 sxs (118 cu.ft.) C1 "B" with 2% CaCl2. Squeeze to 1850 psi.
6. Test casing to 1000 psi. Held OK.
7. Clean out to 2730'.
8. Pick up and run 5-1/2", 15.5#, J-55 casing to 2735', cementing to surface with 250 sxs (295 cu.ft.) C1 "B" with 2% CaCl2. Circulated 3 bbls (17 cu.ft.) of cement to surface.
9. Drill out Bridge Plug. Push to PBTD of 4190'.
10. Land 2-7/8" tubing at 3089'. Run pump and rods. Resume production.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
