1. MIRU PULLING UNIT.
2. BLOW DOWN TBG. KILL WELL W/ WATER ONLY IF NECESSARY
3. NDWH / NUBOP.
4. PU AT LEAST 2 JTS. OF TBG. - TIH TO TAG FOR FILL.
5. TOH STANDING BACK 2-3/8" TBG. (TBG. IS SET @ 3652'. THERE ARE 116 JTS. OF 2-3/8" 4.7# J-55 WITH F NIPPLE @ 3619').
6. PU 4-3/4" BIT ON 2-3/8" TBG. AND TIH TO COTB, CIRC. HOLE CLEAN. TOH W/ SAME.
