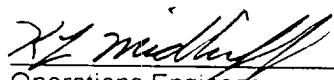

1. Test location rig anchors and replace as necessary. Comply with all NMOCD, BLM, and BROGC safety regulations.
2. MIRU daylight PU. Kill well with 2% KCl water. ND wellhead NU BOP.
3. POOH with 2-3/8" tubing set @ 3226'. RIH with 7" casing scraper to 3474'. POOH.
4. PU and RIH with 7" CIBP on 2-3/8" tubing; set CIBP at 3459'. Load casing with packer fluid (3 quarts Unichem TH 606 per 100 bbl 2% KCl water) and pressure test casing to 500 psi for 30 minutes with a chart.
5. ND BOP, NU wellhead. RDMO PU. Send tubing to yard.

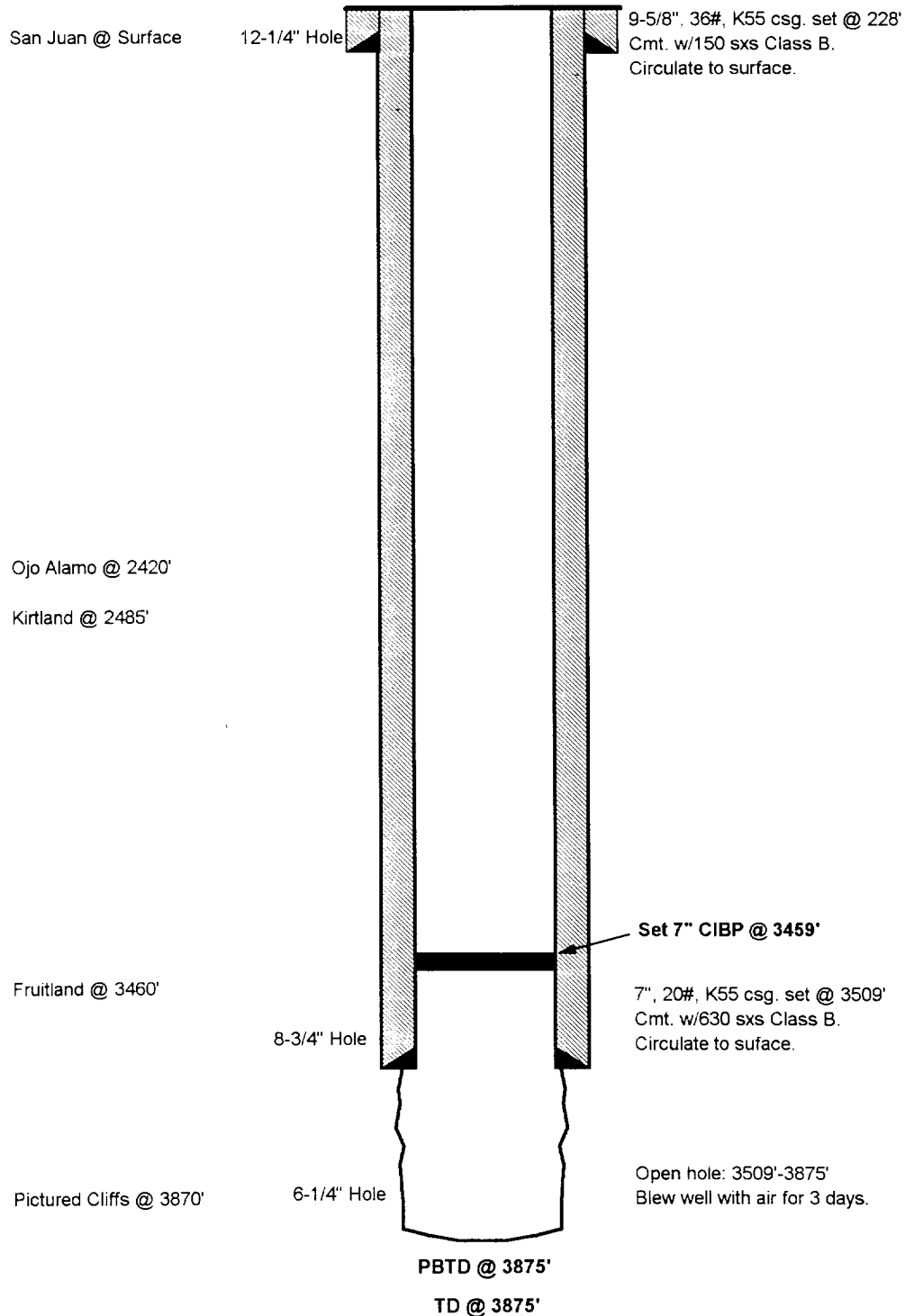
