04-22-89 TD 2555'. Ran 62 jts. 7", 20.0#, K-55 intermediate casing, 2543' set @ 2555'. Cemented with 360 sks. Class "B" 65/35 with 6% gel, 2% calcium chloride, 1/2 cu.ft. perlite/sx (695 cu.ft.) followed by 100 sks. Class "B" with 2% calcium chloride (118 cu.ft.) circulated to surface. WOC 12 hours. Held 1200#/30 min.
