CONVERT EXISTING DC NEGATIVE TO GRENIER 103 FROM GRENIER 6 TO UGAC. PLOW AT A DEPTH OF 18" TO 24" IN ROADWAY A DC NEGATIVE #8 CABLE TO THE GRENIER 6B. ALL WORK WILL BE PERFORMED ON PREVIOUSLY DISTURBED GROUNDS AND WITHIN THE LOCATION BOUNDARY.
