5/11/99 Rig up pulling unit, Pressure test tbq. to 500 #. Held OK. Rig up for rods. Unseated pump, POOH with 129 - 3/4" rods, 2- K bars and pump. NDWH, NUBOP. Pull off tbq. hanger, RIH with one joint of 2 7/8" tbq. Tag fill at 3329'. POOH with 600' of 2 7/8" tbq. Pull tbq. above perfs. SDFN

5/12/99 Open well to pit, rig up wireline. Made 6 runs with string shots. 1st Run 3290' to 3310', 2nd run 3275' to 3290', 3rd 3222' to 3244', 4th 3149' to 3164', 5th 3136' to 3149', 6th 3080' to 3088'. All shot under lubricator. RD wireline. RIH with tbq. tag up on fill at 3329'. No new fill. Land tbq at 3324'. NDBOP, NUWH. RIH with rebuilt pump. 2-K bars and 129- 3/4" rods. Change out stuffing box and radigan. Load tbq, stroke pump to 400#.
