Propose to extend drilling permit with the changes listed below. Drilling permit expires on April 3, 1990. Propose to spud well with 12 1/4" hole and drill to 200' and set 9 5/8" surface casing. Will cement with 150 sx of Class "B" and raise cement to surface. Will nipple up 3000 psi BOP assembly and drill 8 3/4" hole to 2540' with fresh water mud system. Will set 7" casing at 2540' and cement with 350 sx Pozmix followed by 100 sx Class "B" cement. Will nipple up 3000 psi BOP/diverter assembly and drill 6 1/4" hole to TD of 2840' with air and water. Will hang off 5" liner at 3480'-2840'.
