Spud a 12 1/4 surface hole on 7-23-90 at 20:00 hrs. Drilled to 277 '.

Set 8 5/8" 36" K-55 surface casing at 256 '. Cemented with 170 sxs class B w/ 2 9/16" CMC 12. Circulated 6 BBLs to the surface. Pressure tested casing to 2000 psi. Drilled a 7 3/8 " hole to a TD of 3170 ' on 7-27-90. Set 5 1/2" 24" K-55 L7FC production casing at 3157 '. Cemented with (1st stage) 100 sxs class B 65/35 ppc, tail w/ 200 sxs class B neat. (2nd stage) 330 sxs class B 65/35 ppc, tail w/ 60 sxs class B neat. Circulated 1 BBLs good cement to the surface.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.

Item 17: Proposals to abandon a well and subsequent reports of abandonment should include such special information as is required by local Federal and/or State offices.
