3255x5 class B Ashgrove W/2% CACL2. Circulated 15 BBLs to the surface.
Pressure tested casing to 1000 psi. Drilled a 7 7/8" hole to a TD
of 3274' on 8-9-90. Set 5 1/2" 15.5" K-55 LTC production
casing at 3257'. Cemented with 505x5 class B Howco LTC, 65/35p02,
tail w/200 x5 class B Howco standard cement.
Circulated * BBLs good cement to the surface.

Rig Released at 20:00 hrs. on 8-9-90. DV tool set @ 2564'.
* 1st stage circulated 20 BW + 56 BBLs mud. Could not open DV tool
for 2nd stage cement job. Ran CBL from 2556-2092' - no cement
above DV tool. Drilled out DV tool. Tagged cmt. @ 3203'. Drilled out to
3245'. Pressure tested csg. to 2600 psi 10 min. Held. Ran CBL from
3238'-2400'. Cement top @ 2860'.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
