Pressure tested casing to 1000 psi. Drilled a 8 3/4" hole to a TD of 3425' on 12-16-90. Set 7" 23# K-55 production casing at 3408'. Cemented with 590sx class B Halliburton lite tail with 100sx class B steelhead.
Circulated 31 BBLs good cement to the surface.
Rig Released at 4:30 hrs. on 12-16-90.
