This well was uneconomical to produce because of water disposal; this was re-negotiated so that we are now sending water to 32-9. Amoco is requesting one year to evaluate this well based on the Arnaud A #3 which was returned to production in April 1996. On or before the one year time frame, Amoco will compressor test, etc, or plug and abandon the well. Due to the fact that this well was drilled in the early 1990's, we don't believe that we should do a casing integrity test unless one is requested.
