RU Western Company and pmpd 100 bbls MRS-2 pre-flush, 50 bbls Turbo-flow 2 and cemented w/900 sx Class H cement w/40% SF-3, 0.6% CF-18, 0.15% WR-6 and 6# gilsonite/sk mixed @ 15.6 ppg and 1.62 cubic ft/sk. Good circulation thru-out. Plug down @ 2000 hrs on 8-21-91. Bumped plug w/3000 psi - held. ND BOP and set casing slips w/185,000#. RD and released rig @ 0130 on 8-22-91.
