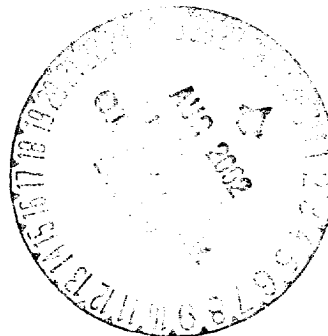

These percentages are based upon reserves assigned to each formation founded on production from the respective formations before and after workover operations. Because an increase was not seen in condensate with the addition of the Mesaverde formation, condensate remains allocated solely to the Dakota formation. 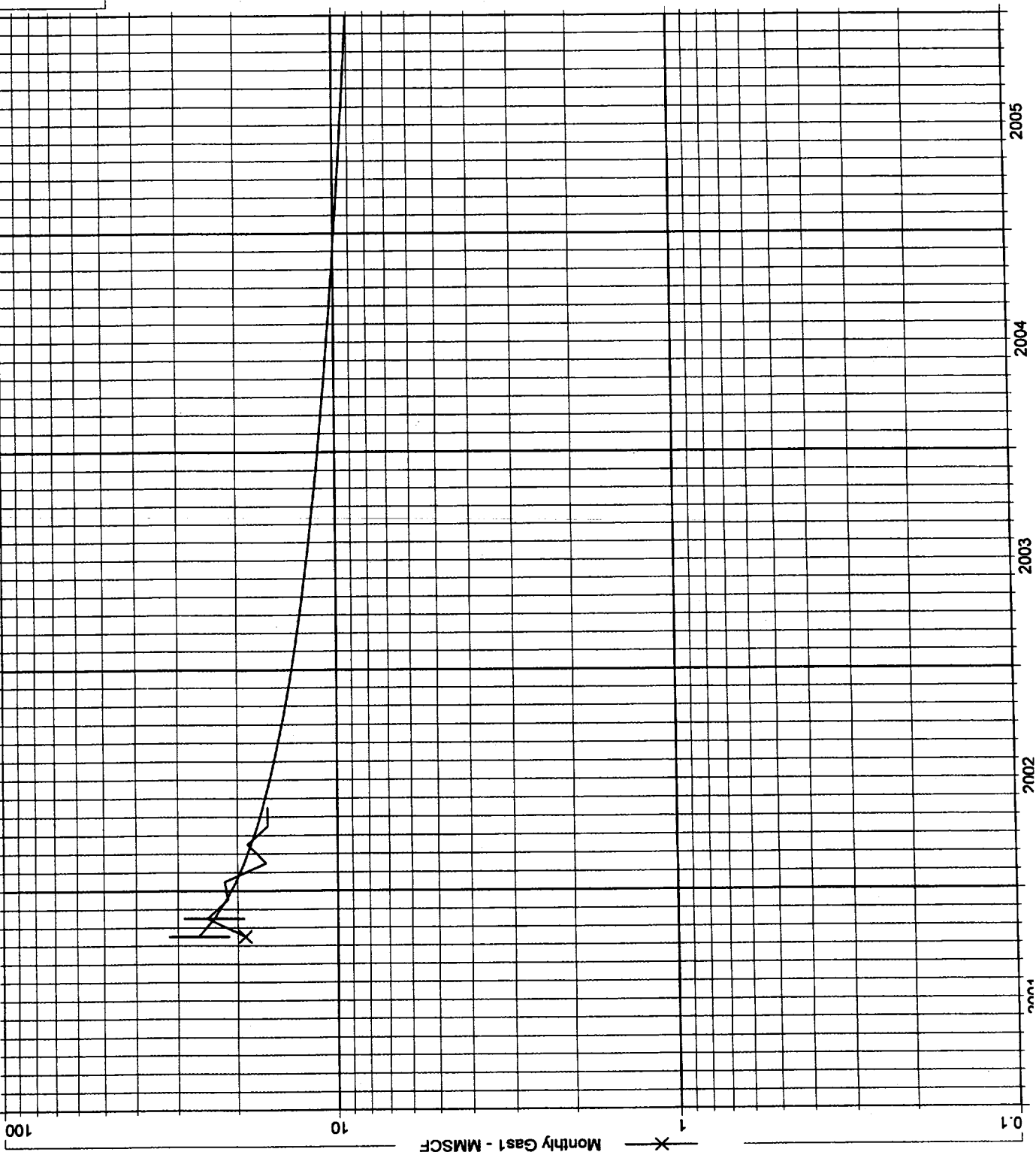
