Pumped 185 sx C1 H + 2% CaCl2 + 1/4#/sx CelloFlake @ 3-4 bpm & 50-110 psi, mixed @ 15.6 ppg w/1.2 yield. Displaced wooden plug w/25 bbls water. Plug down @ 13:35 hrs 12/8/98. Circulated 13 bbls cement to surface. WOC. NU WH & NU BOP. PT blind rams, casing and manifold to 200 psi for 3 min. then to 1500 psi for 10 min. Held OK.
