GIH w/6-1/4" bit & tagged cement @ 3060'. Drilled out cement, then drilled new formation to TD @ 3256'. TD reached 4/27/99. COOH. RIH w/underreamer and underreamed 6-1/4" hole to 9-1/2" hole from 3115' to 3256'. Circulated hole. COOH. Rotated and reciprocated with air & water sweeps for approx. 19 days cleaning out to TD. GIH w/5-1/2" 15.5# K-55 casing (liner) and set @ 3247'. Top of liner set @ 3062'. Total of 185' of liner. Top of hanger @ 3058'. COOH.

RU Blue Jet & perf'd .75" 120 degree phased holes at 4 spf as follows:

3126' - 3143' (17'); 3164' - 3180' (16'); 3198' - 3216' (18') Total 51 feet for 204 holes

RD Blue Jet. RIH w/2-3/8" 4.7# J-55 tubing and set @ 3194' with "F" nipple set @ 3162'. ND BOP & NU WH. PT to 3000 psi for 30 minutes. OK. Pumped off check. RD & released rig 5/17/99. Turned well over to production department.
