RIH w/8-3/4" bit and tagged cement @ 276'. Drilled cement from 276' to 331'. Drilled new formation to 3336'. Circulated hole. COOH. RIH w/7" 20# J-55 casing and landed @ 3326'. RU BJ to cement. Pumped 20 bbls water ahead. Then pumped 440 sx 65/35 sx C1 H POZ w/5#/sx Gilsonite, 1/4#/sx Cello-flake, 6% gel mixed at 10 to 12 ppg. Yield 2.10. Tail pumped - 100 sx C1 H w/5#/sx Gilsonite, 1/4#/sx cello-flake, 0.3% FL-52 and 2% CaCl2. Yield 1.21. 15.6 ppg. Total slurry pumped 187 bbls. Displaced with 134 bbls fresh water. Bumped plug with 1400 spi (7/12/98). Circulated 28 bbls (157 cf) to surface.

NU WH & NU BOPs. PT BOPs, WH & casing to 200 psi 3 min and 2000 psi for 10 min. Good test.
