RIH w/underreamer and underreamed 6-1/4" hole to 9-1/2" hole from 3346' to 3608'. Circulated hole. COOH. Rotated and reciprocated w/air & water sweeps, then naturally surged well for approx. 17 days cleaning out to TD. COOH laying down DP, DCs & BHA. Land donute w/1 jt of 2-3/8" tubing. RD BOP & NU WH. PT- good test. RD & released rig @ 23:59 6/21/99.
