MIRU spud a 13-3/4' hole on 10/30/1999 drilled to 143', set 9.625' 32.3# surface pipe and cemented with 125 sxs CLS B to surface. Good cement circulated to surface with no fall back.

Drill 8-3/4" intermediate hole on 10/31/1999. Drilled to 2,552' and set 7" 20# casing to 2,542'. Cement with 148 sxs Class B lead and tail to surface. Circulated good cement to surface.

Drill 6.250" hole to 5,424'. Run and cement 4.5" 10# liner using 210 sxs CLS A to 2,800'. Run 2-3/8" tubing and land at 5,221'.
