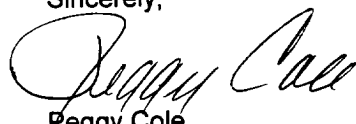

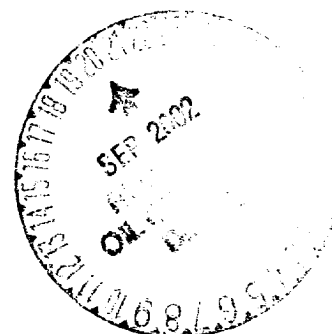
These percentages are based upon reserves assigned to each formation founded on production from the respective formations before and after the deferred completion of the Mesaverde. Because condensate has not changed since the addition of the Mesaverde formation, condensate has remained completely attributed to the Dakota formation.

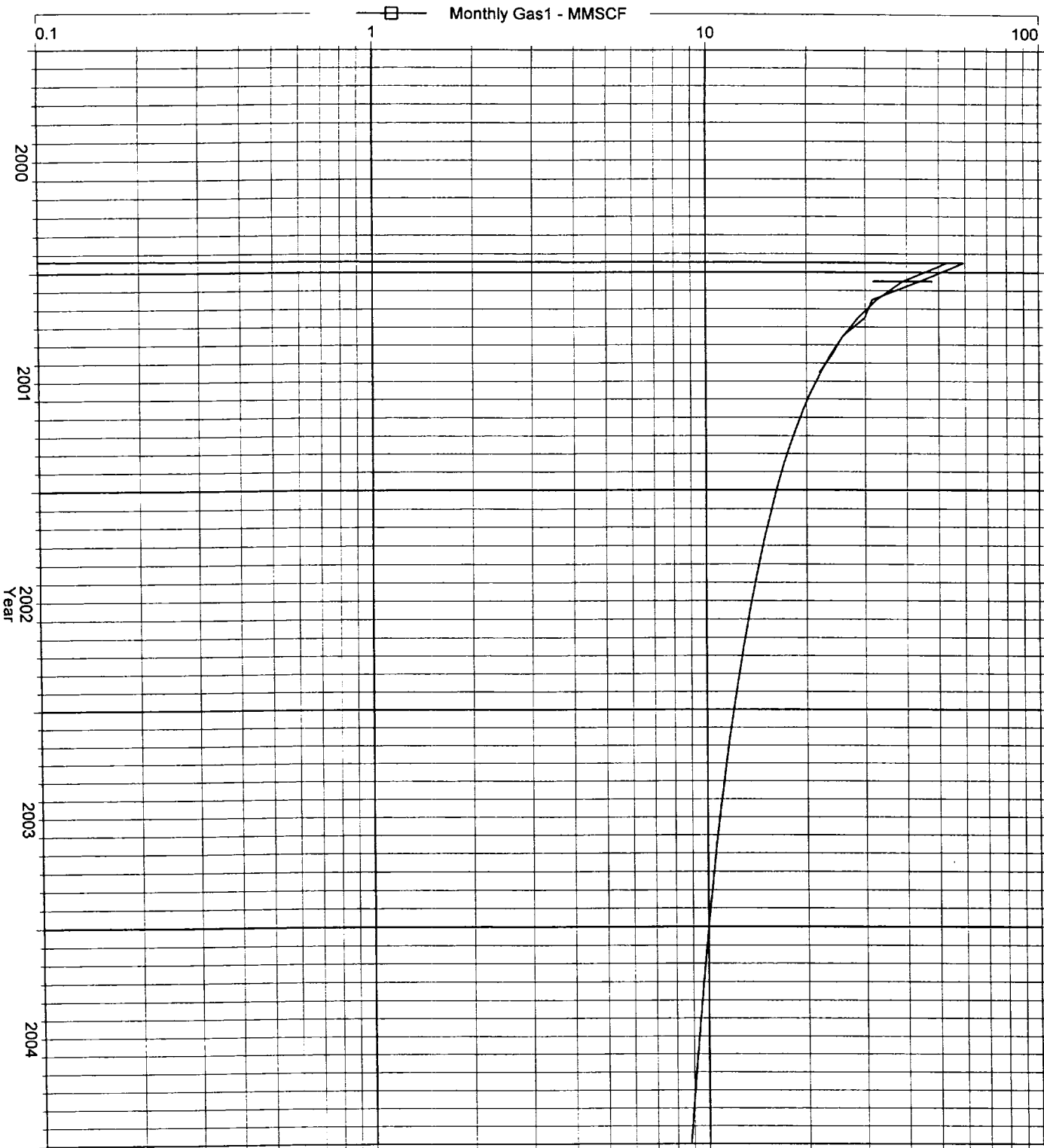
