8-19-00 Cmt d w/285 sx Class "B" neat cmt w/3% D-79, 0.5 pps D-24, 0.1% D-46 (826 cu ft). Tail w/90 sx Class "B" 50/50 poz w/2% D-20, 2% calcium chloride, 0.25 pps D-29, 5 pps D-24, 0.1% D-46 (113 cu ft). Circ 30 bbl cmt to surface. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.
