Tail - 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl2, 0.25#/sx Cello-flake. Displaced with 155 bbls H2O. Plug down at 1643 hrs 6/23/01. Circ. 20 bbls cement to surface.

ND BOP, set slips and cut off casing. NU BOP, manifold and lines. PT BOP, rams and casing to 200 psi low and 3000 psi high. Good test.
