RU to cement. Pumped 5 bbls 2% KCl, 10 bbls gel water, 5 bbls 2% KCl/red dye. Then pumped 185 sx (393 cf - 70 bbls slurry) Type 3 35/65 POZ w/6% gel, 10#/sx CSE, 0.02#/sx Static free, 1% FL-52, 0.3% CD-32, 1/4#/sx Cello-flake. Tail - 50 sx (63 cf - 11.2 bbls slurry) Class H cement w/1/4#/sx Cello-flake, 5#/sx Gilsonite, 0.3% FL-25. Dropped plug and displaced with 97 bbls FW. Bumped plug to 1200#. Float held. No fluid to surface. WOC. ND BOP, Set slips and cut off casing. RD and released rig 8/16/00. Will report casing PT and TOC on next report.
