



Pumped 10 bbls mud clean, 10 bbls FW w/red dye, then 415 sx (986 cf - 175.6 bbl slurry) Type 3 cement 35:65 POZ w/5#/sx Gilsonite, 1/4#/sx Cello-flake, 6% gel, 10#/sx CSE, 3% KCl, 0.4% FL-25, 0.02#/sx Static Free. Tail - pumped 50 sx (87 cf - 12.5 bbl slurry) Type 3 cement w/1/4#/sx Cello-flake, 1% CaCl2. Dropped plug w/135 bbls FW. Plug down @ 1649 hrs. 10/31/00. Circ. 8 bbls cement to surface. WOC. ND BOP. Set slips and cut off 7" casing. NU tubing spools. Test seal to 3000# - OK. NU & RU cavitation stack and equipment. PT 7" casing, rams, lines, and manifold to 200 # - 3 minutes and 1800# 10 minutes. Good test.
