RIH w/8-3/4" bit & tagged cement @ 205'. Drilled cement from 205' to 240'. Drilled ahead to 3330'. Circ. hole. RIH w/7", 20#, J-55 casing and set @ 3327'. RU to cement. Pumped 10 bbls mud clean and 10 bbls FW w/red dye. Then pumped Lead cement - 410 sx (974 cf - 173 bbl slurry) Type 3 cement 35:65 POZ w/5#/sx Gilsonite, 1/4#/sx Cello-flake, 6% gel, 10#/sx CSE, 3% KCL, 0.4% FL-25, 0.02#/sx Static free. Tail pumped 50 sx (70 cf - 12.46 bbl slurry) Type 3 w/1/4#/sx Cello-flake, 1% CaCl2. Dropped plug and displaced w/132.9 bbls FW. Bumped plug w/2000#. Circ. 8 bbls cement to surface. WOC.

ND BOP, set slips and cut off casing. NU WH. PT casing, rams, valves and manifold to 200# - 3 minutes and 1800 # 10 minutes - good test.
