(7-4-01) Cmdt 2nd stage w/411 sx 50/50 Class G/TXI w/2.5% sodium metasilicate, 2% calcium chloride, 10 pps gilsonite, 0.5 pps cellophane (1060 cu ft). Circ 80 bbl cmt to surface. PT BOP & csg to 1500 psi/30 min, OK. Drilling ahead.

(7-5-01) Drill to TD @ 6115'. Blow well clean. TOOH. TIH w/58 jts 4-1/2" 11.6# J-55 LT&C csg, set @ 6114'. Lnr top @ 3638'.

(7-6-01) Cmdt w/246 sx 50/50 Class G poz w/4.5% gel, 0.25 pps celloflake, 5 pps gilsonite, 0.25% fluid loss, 0.35% dispersant, 0.10% antifoam (352 cu ft). Circ 5 bbl cmt to surface. ND BOP. NU WH. RD. Rig released.
