Application was amend on 01/09/2001 requesting permission to deepen into the Basin Dakota Pool and commingle production downhole with the Mesaverde Pool. An amendment to the drilling and completion program was submitted on 05/27/2001.

As of this date drilling operations have not commenced on the subject well, therefore, we respectfully request an extension to the drilling permit to allow for the drilling of this well.
