

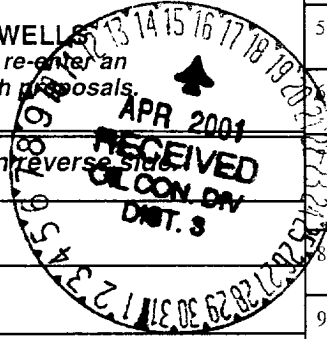

Cross Timbers Operating Company spudded a 12 1/4" hole @ 8:45 p.m. (MST), 3/20/01. Drilled to 368'. Rigged up and ran 8 joints of 8 5/8", 24.0#, J-55 casing. Landed casing @358' KB. Cemented casing w/250 sx Type III cement w/2% CaCl2 & 1/4# sx celloflake (14.8 ppg 1.35 cuft/sx). Circulated 15 barrels cement to surface. NU BOP's.
