Cmdt w/247 sx 50/50 Class G poz w/4.5% gel, 0.25 pps celloflake, 5 pps gilsonite, 0.25% fluid loss, 0.35% dispersant, 0.1% antifoam (353 cu ft). Circ 5 bbl cmt to surface. ND BOP. NU WH. RD. Rig released.
