During drilling operations, hole conditions dictated a change in cement slurry on the intermediate 7" casing. It is intended to run a tail cement of 50/50 Poz instead of neat cement. Additives will remain the same except CaCl2 will be run to accelerate the setting time. Compressive strength in 24 hours will be 1950 psi. Volume may be increased to accommodate hole wash out. It is still planned to circulate to surface eventhough number of sacks may vary for operational plan.
