7/5/02 MIRU Key #18 (cavitation rig). NU BOP, manifold and lines. Test 7" casing, rams and manifold to 200 psi - 3 minutes and then tested 500 psi for 30 minutes & 1800 psi for 10 minutes. Good test. RIH w/bit & D/O 7" cement shoe @ 3305'. Drilled ahead to 3498' TD. TD reached 7/9/02. RIH & tagged fill @ 3470'. Started Rotating and reciprocating w/air, mist & foamer cleaning out to TD. Surged & R/R well for approx. 16 days. C/O to TD @ 3498'. RIH w/5-1/2" 15.5# J-55 casing (liner - 218') and hanger. Set Hanger @ 3267' & liner set @ 3490'. Has approx. 38' of overlap into 7" shoe. COOH. RU Blue Jet & perforated liner @ 4 spf .75" holes - 3336'-40'; 3344-46'; 3350-51'; 3392'-3406'; 3411'-15'; 3428'-3438'; 3456'-58' = 37' and 148 holes. RD Blue Jet. RIH & C/O fill to PBTD @ 3488'. COOH. RIH & 2-3/8", 4.7# tubing and set @ 3447'. ND BOP, NU WH. RD & released rig 7/29/02. Turned well over to production to first deliver.
