Pumped a preflush of 5 bbls water, 10 bbls mud clean and 10 bbls dye water ahead of 150 sx (211 cf - 37.57 bbl slurry) Type 3, 2% CaCl₂, 0.25#/sx Cello-flake. Plug down @ 1527 hrs 6/10/02. Circ. 15 bbls cement to surface. WOC. NU WH & NU BOP. PT-OK. RIH w/bit & PT rams and casing to 200 psi low and 1500 psi high. Good test.
