RIH w/8-3/4" bit & D/O cement & shoe to 225', then drilled ahead to 3353'. Circ. hole. RIH w/7", 20# J-55 casing and set @ 3342'. RU to cement. Pumped preflush of 10 bbls water, 10 bbls mud clean & 10 bbls dye water ahead of Lead - 430 sx (1023 cf - 182 bbl slurry) Premium Lite High Strength FM, 3#/sx CSE, 5#/sx Gilsonite, 0.25#/sx Cello-flake, 3% Potassium Chloride, 0.4% FL-25. Tail - pumped 50 sx (70 cf - 12.46 bbl slurry) Type 3, 1% CaCl2, 0.25#/sx Cello-flake. Displaced w/133 bbls of water. Plug down @ 0818 hrs 6/13/02. Circ 10 bbls cement to surface. ND BOP, set slips and cut off casing. RD & released rig 6/13/02. Will show casing PT on next report.
