7-16-2002 Run 6 jts (253') 9-5/8", 36# J55 STC csg w/cmt nose guide shoe (thread locked), 1 jt w/insert float (thread locked) and arc welded coupling w/6 centralizers. Land csg @ 273' KB and float @ 229' KB w/20' landing joint.
Cmt csg w/25 bfw, 17 sx (37 bbl) CIs B w/2% Cacl2 & 1/4# sx cellophane mixed to 15.6 ppg & yeilding 1.18 cuft/sx. 17.8 bfw to displace plug. Float held. Circ 18 bbl cmt. WOC. Nipple up Wellhead and BOP. Test BOP, csg, inside & outside manifold valves, kill line to 1,000 psi. Held OK.
