12/30/88 - Set retainer @ 5240' and spotted 20 BBLs. of 9# drilling mud. Spotted 25 sacks on top of bridge plug, hand pulled up to 4610'; spotted 25 sacks cmt for next plug to 4510'. Pulled out to 3100'.

1/04/89 - Perfed 4 holes @ 3100'. Pumped 80 BBLs. 9# mud. Set 7" retainer, tagged last plug.

1/05/89 - Pumped 50 sxs cmt below retainer & 25 sxs on top of retainer. Perf @ 2700' with 4 holes. Set cmt retainer @ 2653'. Spotted 50 sxs Class "B". Circulated 50 BBLs. of 9# mud. Spotted 25 sxs Class "B" on top of retainer. Pulled out of hole @ 2514'. Perf @ 1370'.

1/07/89 - Ran 7" retainer @ 1130'. Pumped 75 sxs Class "B" cmt below retainer & spotted 40 BBLs. 9# mud above retainer. Perfed 4 holes @ 287'. Circ cmt to surface w/125 sxs Class "B" cmt.

1/10/89 - Cut off wellhead and placed dry hole marker.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

Item 4: If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
