**This well was drilled and plugged in 1961 by Arizona Exploration Inc. under designation of operator from Forest Oil Corporation. Subsequent inspection of the location by Jerry Long of the U.S.G.S. revealed that the marker had been knocked over revealing no surface plug in the hole. Forest Oil was informed of this problem and the request to install a 10-sack cement plug in the surface casing and erect a dry hole marker was passed on to Continental Oil Company on July 21, 1964. Continental purchased Arizona Exploration Inc. in December 1961, so we assumed the proper plugging obligation.**

**On September 4, 1964, a 10-sack cement plug was installed in the surface casing and the dry hole marker was installed. The well site is now ready for final inspection.**

## Instructions

**General:** This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.

**Item 4:** If there are no applicable State requirements, locations on Federal or Indian land should be described in accordance with Federal requirements. Consult local State or Federal office for specific instructions.
