As a result of the above well being unable to produce commercial quantities of gas, it was plugged and abandoned on August 5, 1976, as follows:

1. Cement retainer set at 1024'.
2. Pumped 415 sacks of Class "B" cement below retainer.
3. Pumped 20 sacks cement plug at 1024'.
4. Set 30' cement plug at surface.
5. Erected abandonment marker.

A 1172' fish of 1-1/4" tubing and a 4-5/8" x 5' cable tool bit were left in hole.

We are waiting for your instructions for surface restoration.

Instructions

General: This form is designed for submitting proposals to perform certain well operations, and reports of such operations when completed, as indicated, on Federal and Indian lands pursuant to applicable Federal law and regulations, and, if approved or accepted by any State, on all lands in such State, pursuant to applicable State law and regulations. Any necessary special instructions concerning the use of this form and the number of copies to be submitted, particularly with regard to local, area, or regional procedures and practices, either are shown below or will be issued by, or may be obtained from, the local Federal and/or State office.
