This well is an open hole, nitroglycerine completion. It is proposed to sidetrack, redrill, case, and fracture complete the Mesaverde formation according to the plan below:

- Set a 400' plug from 4994-4594' and a CIBP @ 4550'.
- Perforate 7" casing @3100' and circulate cement to surface (305 sxs).
- Set whipstock and mill window @ 4300'.
- Drill to 5600' with air.
- Run 4-1/2" casing from 5600' to surface and cement up to 3300'.
- Fracture complet Mesaverde and return to production.
