DETAILS OF WORK

This well has been drilled to a Total Depth of 1267' and fully tested without encountering any commercial oil or gas pay. Well to be plugged as follows: 1261' - 1277' with 25 sacks cement. Will run free point indicator, cut off and pull 3" OD casing. Will set 25 sack cement plug where casing is cut off. 5 sack cement plug to be set in top of 8-1/2" OD surface casing with 4" pipe marker extending 4' above ground level.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
