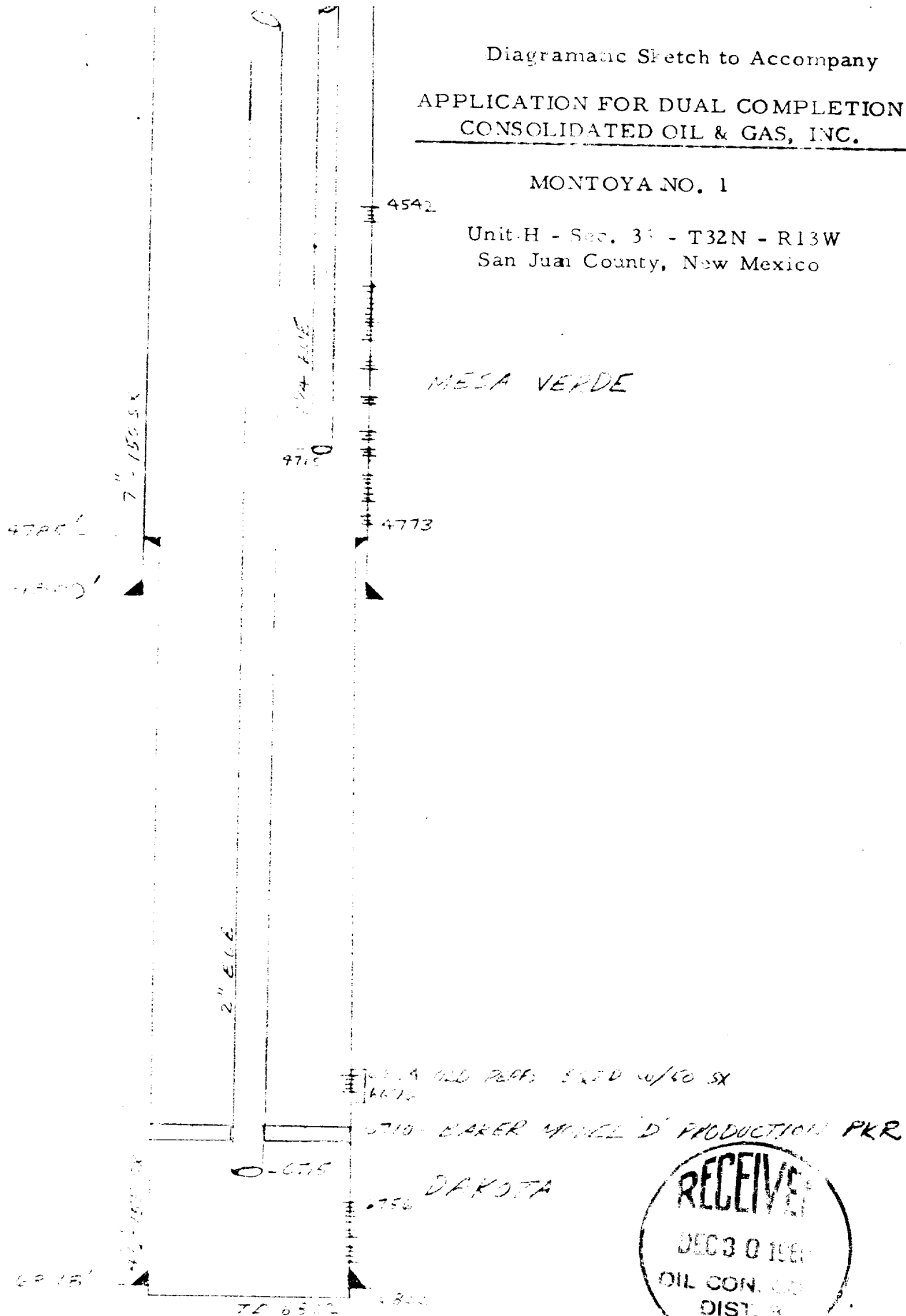

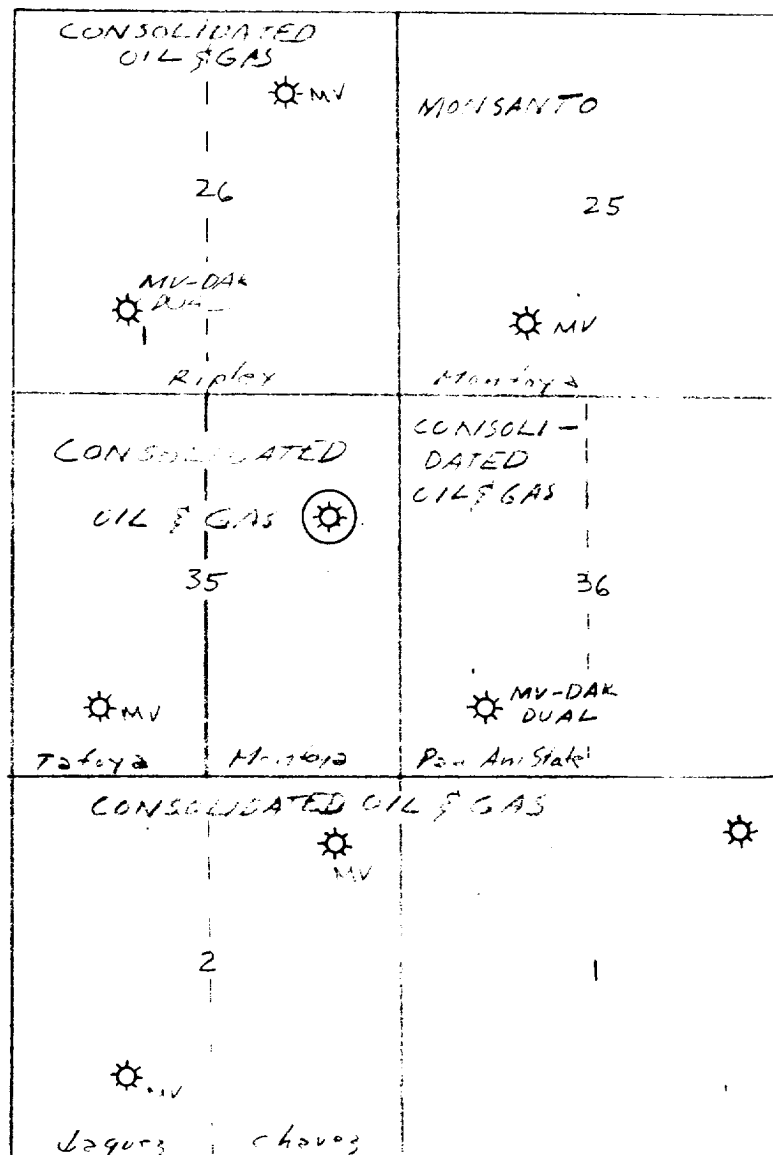


Plat to Accompany
